Within 5 days after adoption of an ordinance increasing water or sewer rates and charges, owners of property connected to the Town’s water or sewage works, who attend the public hearing on February 12, 2024, pursuant to Indiana Code Section 8-1.5-3-8.2(b), may file with the Town, a written petition objecting to the rates and charges.
