**RESOLUTION 2023-9**

**AN RESOLUTION AUTHORIZING AN ADDITIONAL APPROPRIATION FOR 2023**

**WHEREAS**, except as expressly provided in Indiana Code Chapter 6-1.1-18, the proper officers of a political subdivision shall appropriate funds in such a manner that the expenditures for a year do not exceed its budget for that year as finally determined;

**WHEREAS**, pursuant to Indiana Code Section 6-1.1-18-5, the proper officers of a political subdivision may, through proper procedure, appropriate more money for a particular year than the amount prescribed in the budget for that year as finally determined;

**WHEREAS**, moneys appropriated as part of Morgantown's approved 2023 budget are insufficient to pay all necessary expenses in 2023, requiring additional money to be appropriated for 2023;

**WHEREAS**, the Town has previously unappropriated funds available;

**WHEREAS**, the Town Council, after having properly noticed and conducted a public hearing on December 28, 2023, now chooses to appropriate and make available in Fund No. 1101, the Town's General Fund, to be spent in 2023, an additional \$30,000.


**ACCORDINGLY, BE IT RESOLVED** by the Morgantown Town Council that **\$30,000** is hereby added to **Fund No. 1101**, the Town's **General Fund**, and appropriated, as an additional appropriation to the Morgantown 2023 Budget, to be spent in 2023,
