## TOWN OF MORGANTOWN, INDIANA ORDINANCE NO.

### AN ORDINANCE AMENDING THE RATES AND CHARGES FOR THE MORGANTOWN WATER UTILITY

WHEREAS, the Town of Morgantown, Indiana ("Town") operates a water utility;

**WHEREAS**, the Morgantown Town Council ("Council") is the governing board of the Town's water utility and as such sets reasonable rates and charges sufficient to pay all legal and other necessary expenses incident to the operation of the utility;

**WHEREAS**, prior to its repeal by the Indiana General Assembly, by way of adoption of HEA 1002, the Town's water utility was subject to a utility receipt tax, which was a component of its current rates;

WHEREAS, as of January 1, 2022, the Town's water utility was not under the jurisdiction of the Indiana Utility Regulatory Commission for the approval of rates and charges;

**WHEREAS,** effective as of July 1, 2022, the utility receipt tax will no longer be an expense of the Town's water utility;

WHEREAS, pursuant to Indiana Code Section 8-1-2-4.3, added to the Indiana Code by adoption of HEA 1002, a utility that is subject to the utility receipts tax under IC 6-2.3 and is not under the jurisdiction of the Indiana Utility Regulatory Commission shall adjust it rates and charges to reflect the repeal of the utility receipts tax

## ACCORDINGLY, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MORGANTOWN, as follows:

The Rates and Charges as shown on Appendix A, attached hereto, are hereby approved and adopted.

The Rates and Charges adopted herein, as shown on Appendix A, shall become effective upon adoption of this Ordinance and for the consumption period that includes July 1, 2022.

Ordinance 2015-09, and all other prior ordinances of the Town's water utility, to the extent they have not been repealed and are not in conflict herewith, remain in full force and

effect. All ordinances, to the extent they are in conflict herewith are repealed as of the date of adoption of this Ordinance.

Introduced and fully adopted, on final reading, this 13th day of June, 2022.
