### ORDINANCE 2023-5

#### AN ORDINANCE AUTHORIZING AN ADDITIONAL APPROPRIATION FOR 2023

WHEREAS, except as expressly provided in Indiana Code Chapter 6-1.1-18, the proper officers of a political subdivision shall appropriate funds in such a manner that the expenditures for a year do not exceed its budget for that year as finally determined;

WHEREAS, pursuant to Indiana Code Section 6-1.1-18-5, the proper officers of a political subdivision may, through proper procedure, appropriate more money for a particular year than the amount prescribed in the budget for that year as finally determined;

WHEREAS, moneys appropriated as part of Morgantown's approved 2023 budget are insufficient to pay all necessary expenses in 2023, requiring additional money to be appropriated for 2023;

WHEREAS, the Town has previously unappropriated funds available;

WHEREAS, the Town Council now chooses to appropriate and make available in Fund No. 2201, the Town's Motor Vehicle/Highway Fund (MVH), to be spent in 2023, an additional \$15,000.

ACCORDINGLY, BE IT ORDAINED by the Morgantown Town Council that \$15,000 is hereby added to Fund No. 2201, the Town's Motor Vehicle/Highway Fund (MVH), and appropriated, as an additional appropriation to the Morgantown 2023 Budget, to be spent in 2023,

Introduced and adopted as presented, by unanimous consent and vote of at least four (4) Town Council members, present, on the 13<sup>th</sup> day of November, 2023
