RESOLUTION 2023-01

A RESOLUTION ADOPTING A MASTER PLAN

WHEREAS, the Morgantown Town Council, by way of adoption of Ordinance 2022-03, on May 9, 2022, established for Morgantown a Department of Parks and Recreation ("Park Department") and Park and Recreation Board ("Park Board);

WHEREAS, members have been appointed the Park Board and their respective initial terms set;

WHEREAS, the Park Board shall exercise general supervision of and make rules for the Department, shall establish rules governing the use of the Town's park and recreation facilities by the public, and shall otherwise carry out its duties as provided under IND. CODE §§ 36-10-3-10 and 11, subject to the legislative, budgetary, and salary setting authority of the Town Council.

WHEREAS, the Park Board members have been made aware of efforts by Town representatives, in partnership with the Eppley Institute for Parks and Public Lands and the Center for Rural Engagement at Indiana University to create for the Town a Parks and Recreation System Master Plan (the "Morgantown Master Plan");

WHEREAS, the Morgantown Master Plan, dated January 2023 has been completed and presented to the Town in final draft;

WHEREAS, the Park Board members have reviewed the Morgantown Master Plan and familiarized themselves with its purpose and goals and deem it to be acceptable.

ACCORDINGLY, BE IT RESOLVED, by the Parks and Recreation Board for Town of Morgantown, Indiana that the Morgantown Master Plan, dated January 2023, in the form attached hereto is approved and adopted.
