The special meeting was called to order by Council President, Joe Blevins at 6:00 p.m. The members present were; Jeremy Baker, Jewel Blevins and President, Joe Blevins. Absent was Council members were; Courtney Allen and Stacie Baker. Also present was Clerk Treasurer, Sharon McIntosh.

YEAR END CLAIMS

Council member, Jewel Blevins made a motion to approve Claims dated December 29, 2025 for \$237,237.46. The motion was seconded by Council member, Jeremy Baker. All members present voted in favor of the motion.

PARK INVOICE

Fleis & Vanderbrink submitted invoice #869510 for professional services for the park. This invoice will be paid with park funds in January 2026. Council member, Jewel Blevins made a motion to approve payment of the invoice #869510 in January 2026. The motion was seconded by Council member, Jeremy Baker. All members voted in favor of the motion.

WATER PROJECT INVOICE

An invoice from Fleis & Vanderbrink #76278 for \$26,500.00 to be paid with SRF funds was presented to the Council for approval. Council member, Jewel Blevins made a motion to approve the claim. Council member, Jeremy Baker seconded the motion. All members voted in favor of the motion.

DIGITAL

Council member, Jewel Blevins made a motion to approve paying the sign invoice from Green Sign Company for \$31,548.47. The motion was seconded by Council member, Jeremy Baker. All members voted in favor of the motion.

PUBLIC COMMENT

Resident, Jeff Downey asked numerous questions to the Clerk Treasurer and the Town Council concerning the Clerk's duties managing the Utilities and various other items he felt were an issue for him. The Council members spoke up defending the numerous complaints Jeff made.

Resident, Penny Anderson asked numerous questions and complained about the Town using Suzy Bass to balance the Bank Statement. Penny believes that Becky Smith should be able to do that job. The Clerk Treasurer never said that Becky Smith would balance the Bank Statement the Clerk said it might be a possibility in the future but Becky would have a lot to learn in the Fund program before she would be able to attempt that. Becky does not even have the Fund program at this time. The State Board of Accounts likes the idea the Town has a 3rd party balancing the Bank Statements.


The meeting was adjourned by Council President, Joe Blevins.
